BUDGET MEETINGS BEGIN

The Board of Commissioners will hold several workshops in an effort to begin the planning process for the Town's 2010-11 budget. These meetings will be held on April 27 (7:30pm), April 29 (7:00pm), May 4 (7:00pm), May 6 (7:30pm), and May 11 (7:00pm). The final proposed budget will be presented to the Board and the citizens at the regular Board of Commissioners meeting on May 18, 2010. The budget must lay open for comment prior to being approved. Traditionally, the Board of Commissioners votes on the budget in a final vote at the June meeting.

Budget meetings are open to the public.

WHEN IS HARDEES COMING?

We know you're wondering – because you've asked! So here's your official update. At the March Board of Commissioners meeting, the Board approved a resolution which grants the contract for placing sewer lines along the west side of US 1 (from Pocomoke Road to Green Street). The next step will be the actually process of putting the pipes into the ground, which actually shouldn't take very long. Once that is done, Bodde Noell Enterprises can begin their work on their site. The target date the Town has been given is August 2010.

However, keep in mind this project is about more than just one restaurant. By placing sewer lines along this side of US 1, we are able to open several additional parcels of land to development, which hopefully will entice additional development. Keep an eye out for future developments!

You Can Recycle Your CFL Bulbs Right Here!

CFLs and tube fluorescent lights (like those found in Town Hall and the Town Hall Annex) contain mercury, which is a dangerous element that can poison humans and animals with even the slightest of contact. Proper disposal of such semihazardous material is key to ensuring a safe living and working environment. Currently, there are programs in our region for recycling mercury bulbs, including Home Depot's CFL recycling program, and Wake County's bulb site in Knightdale. However, there really is nothing of convenience to the citizens of Franklin County, much less Franklinton, which is what prompted the Town to create, for **Town residents**, a mercury bulb recycling

Town residents who have CFLs that have burned out may bring them to Town Hall during regular business hours (Monday - Friday, 8:30am - 5:00pm) to be recycled. If you have a fluorescent tube light, you may bring it (or them) to the Public Works Department on S. Chavis St. on Tuesdays between 7:00am and 9:00am. Please help us protect your living environment and the residents of our Town by correctly disposing of mercury based light bulbs and using this new Town service!

Novozymes Named Top Business Partner by NC SMT Education Center

On April 17, Novozymes will be given the 2010 Business Partnership award by the North Carolina Science Mathematics and Technology Education Center. The Burroughs Wellcome Fund launched the SMT Center in 2002. A 22-member board of directors comprising N.C. leaders in education, business, and government oversees the Center. The mission of the NC SMT Center is to systematically improve performance in science, mathematics, and technology pre K-12 education as a means of providing all children in North Carolina with the necessary knowledge and skills in science, mathematics, and technology to have successful careers, be good citizens, and advance the economy of the state. The SMT Awards are given each year in multiple categories including outstanding educators, business partners, and community partners.

Novozymes was selected for the Business Partnership award because of their outstanding corporate partnerships with local schools in Franklin County and beyond over their 30+ years in North Carolina. Upon locating their North American headquarters in Franklinton, Novozymes (then Novo) partnered with Franklinton High School to build a greenhouse, and provide supplies for AP science classes to be taught. Novozymes has since been host to multiple site visits and job shadowing opportunities, and most recently provided Franklin County Schools with funds to build a new biotechnology laboratory in the new Franklinton High School, currently under construction.

Franklinton Mayor Elic Senter, a member of the NC SMT Center Board of Directors, will present the award to Novozymes North America President Adam Monroe at the ceremony. Mr. Monroe will be welcomed to the Franklinton community at a reception prior to the Franklinton Board of Commissioners meeting on Tuesday, May 18, 2010 at 6:00pm. The public is invited to attend.

The NC Senior Health Insurance Information Program (SHIIP) Counseling site at the Franklinton Senior Center spent the month of March problem solving. The Federal Centers for Medicare and Medicaid Services (CMS) closed the Fox Insurance Company Prescription Drug Plan (PDP) on March 9th. 24,000 North Carolinians were affected and 193 Franklin County residents were affected. Many of the problems developed as Fox members were

asked to pay full price for prescriptions. If you are having problems with vour current Prescription Drug Plan or Medicare Advantage Plan please give us a call, 494-5611. We work closely with the Raleigh SHIIP office who then work directly with the Atlanta offices of CMS.



Brandon Madden with the NC Department of Justice talked about how to prevent frauds and scams with over 50 seniors who were present at the center for our annual St. Patrick's Day celebration. Letter from the Desk of Police Chief John Green

Dear Citizens:

Like most of you, I welcome the coming of spring and hope this letter finds everyone in the best of health. With the onset of warmer weather families will be planning vacations. I would like to remind our citizens that if you contact Ms. Susan Cothran at the police department you can have your homes placed on our property check list for officers to keep a special eye on your property, so that you enjoy your time away from home with an extra confidence.

As I know many of you are aware, during the month of March, the police department responded to three different shooting incidents within city limits. First and foremost, I want to assure all of our citizens that your police department is investigating each of these incidents with all of the resources at our disposal to insure the arrest and conviction of the individuals responsible for perpetrating these crimes. Like many cities across the country, we are finding ourselves with drug and gang problems, which inevitably leads to the types of crimes we have being experiencing. Recognizing the problem is the first step in finding a solution to the problems we now face. It takes a joint effort between citizens, police and the judicial system to combat this ongoing problem. The police department welcomes your input and cooperation to keep our streets, schools, and businesses safe.

I would like to end on a positive note; recently Sergeant Wade Bulloch was named American Legion Post 52 Officer of the Year. Sgt.
