Economic Recovery Road Project Awarded to Rep. Allen's District

\$2.3 million project expected to be finished this year

RALEIGH, NC - Representative Lucy Allen is pleased to announce that Franklin County will receive a \$2.3 million transportation project to aid in the state's economic recovery. The money will be used for the milling, resurfacing and guardrail and shoulder reconstruction of 8.1 miles of N.C. 98 and 1.7 miles of U.S. 1-A in Franklin County . The \$2.3 million recovery project contract was awarded to Blythe Construction Inc. of Charlotte . Work can begin as early as March 15, 2010, and is scheduled to be finished by Nov. 1, 2010.

"This welcome news comes on the heels of a previous announcement made just last month that Stimulus funding has been authorized for the widening of a section of US-401 Highway, which is scheduled to being in February. We need better roads and we need good jobs. These investments help with both," Representative Allen said. "It will be money well-spent."

These latest projects were among 34 transportation projects announced on Monday. The total cost value of the projects is more than \$107 million.

According to the Federal Highway Administration, every \$1 million spent on transportation creates 30 jobs, and according to the construction industry, every dollar invested in transportation generates \$6 in economic impact.

Representative Allen is in her fourth term representing Franklin, Halifax and Nash counties in the House of Representatives. She is Chair of the Environment and Natural Resources Committee and Vice-chair of Local Government I and Water Resources and Infrastructure Committees, as well as Vice-chair of the Appropriations Subcommittee on Transportation.

What is the Round Up program? Round Up Franklinton is a program of the Town of Franklinton to provide an opportunity for citizens to make contributions on a monthly basis to the Uptown Revitalization Committee, the Arts Alive Committee, or the Tree Committee. Contributions can be made in two ways. Citizens can contribute by 'rounding up' their monthly utility bill – in other words, if your bill is \$54.50, you can round up the additional \$0.50 to 'round up' your bill to \$55, and the additional \$0.50 would be donated to one of the three committees, of your choosing. You can also contribute by making a flat dollar figure contribution, such as a monthly contribution of \$5, which would be donated to one of the three committees, of your choosing.

The Franklinton Senior Center has new office hours for 2010. The office will open at 8 am and we will close for the day at 5 pm. For any of the services listed below please give us a call at 494-5611.

The Franklinton Senior center continues to offer services to help Medicare Beneficiaries. Through the

North Carolina Department of Insurance, the Senior Health Insurance Information Program is a resource to help you with Medicare issues. We now have two volunteer counselors that you can meet with. Please give us a call to schedule an appointment.



Medicare beneficiaries may be eligible for the federal Extra Help low income subsidy program if he/she has limited income and resources. The Extra Help program can increase cost savings by paying for all or part of the month premiums, annual deductibles, and provide lower prescription co-payments under a Medicare prescription drug plan. To qualify for Extra Help, the annual income must be limited to \$15,600 for an individual (\$21,000 for a married couple living together). Additionally, the total resources must be limited to \$12,510 for an individual (\$25,010 for a married couple living together). The resources do not include a primary residence or a vehicle. If you or someone you know may be eligible please schedule an appointment to complete the application.

Free AARP tax service will be available every Wednesday afternoon, beginning February 3rd, until April 14th. Rich Heroux will be assisting those 60 and up who need help completing and filing their tax returns. Please give us a call to schedule your appointment.

Ann Goswick resumes her water color painting class. A new six week schedule begins Friday, Janu-
