SCAM ALERT

Recent high winds that caused damage to Franklinton Baptist Church and vehicles at Franklinton Day Care also brought scam artists to Town. Workmen come knocking with the offer to inspect your roofing and make minor repairs for a nominal fee. In most cases they do little or no work for this fee and recommend other costly and unnecessary repair work. Other common scams include those offering paving and flooring at greatly reduced costs because they have "leftovers from another job and are only in town for one day."

In general, most legitimate companies will not come to you unsolicited offering work and most do not charge for estimates. You can deter these individuals by asking to see a copy of their business license from the Town and to see their Driver's License or ID Card.

Though the world economy has taken a hit, fortunately, we're pretty sound here in Franklinton. We're about to start the budgeting process, but thankfully, we're not having to go back and cut to make up for a deficit. That speaks volumes of our budget

I hope this finds you all doing well managers and department heads, and their hard work being fiscally responsible with the dollars that *you* entrust with them, and the Board.

As you may be aware, we recently opened our Town Hall Annex, which we will 'officially' open on February 17. (Thanks to the 6 inches of snow we got, not only did the ribbon cutting get pushed back, but Raymond Bragg and his crew *FINALLY* got to use those snow plows!) We're all very excited about the Annex as it will bring much needed office and work space to the municipal office building (which is what we refer to as Town Hall) and a much larger meeting space so that more of you can be involved in the business of our Town. So please, come out and join us!

We still have lots of irons in the fire, but looking at what has been accomplished in 2009 does make me proud of the work that's been done. The base fees for water and sewer usage have been lowered to promote conservation, and the Town is in the process of obtaining grant funds to promote a water reuse project in conjunction with the Olde Liberty Golf Course. The URC again hosted the fall festival, Frankenfest on Main, as well as unveiled the Downtown Redesign plan. Progress Energy Offers Tips to Lower Energy Usage and Costs

Progress Energy encourages customers to take control of their monthly electricity bills. Here are some tips that can help:

Heating tips

• Keep your thermostat at the lowest comfortable setting. Progress Energy recommends 68-70 degrees. Every degree above 70 degrees increases your energy costs by 3 to 5 percent.

• If you have a heat pump, adjust your thermostat in small increments to avoid the operation of the supplemental heat strip in your system. Energy consumption is much higher when the heat strip is in use. A steady setting on your heat pump thermostat produces constant comfort and minimizes the use of the less efficient resistance heat strip.

• Set your thermostat back 10 degrees at night or when you're out for long periods during the day (8-10 hours). Doing so can save as much as 10 to 20 percent in heating costs. Programmable thermostats can automate this process, saving time and money. Put an extra blanket on beds and wear sweaters inside to help keep you and your family comfortable.

• Install your thermostat on an inside wall and away from windows and doors, to keep it from overcompensating and running continuously.

• Keep the fan on your central heating unit set to the "auto" position. Leaving the fan on all the time can add \$25 a month to your electricity bill.

 Clean or replace filters every month. Dirty filters can increase operating costs by 20 percent by making the system work harder to provide warm air.

• Use ceiling fans in winter to distribute heat around a room. Reverse the fan direction from summer cooling.

• Close your fireplace damper when not in use. Consider glass doors to help prevent heat loss when your heating system is on.

• Make sure registers and returns are not blocked by furniture or draperies.

• Use insulated or heavy curtains on windows facing the north side of the house. Keep curtains and shades closed at night and on cloudy days.

• Caulk, seal and weather strip all openings from your home to the outside. Eliminating air leaks in your home can save you up to 10 percent in energy costs.

POLICE DEPARTMENT

The Franklinton Police Department is excited numerous projects to improve the Police Department in the coming months.

Traffic complaints are a priority for patrol officers. With increased traffic volume, they will continue to target speeding violations throughout Town. The Police Department has purchased a hand-held RADAR unit and working with members of the Board and Public Works, secured the use of a traffic trailer from the NC Highway Patrol to help with speed enforcement. The Police Department will also continue to target impaired drivers and drivers with no license by continuing to participate in the Governor's Highway Safety Program 's "Booze It and Lose It" and" No Need to Speed" campaigns.
